Course Description

Machine learning is all about finding patterns in data to get computers to solve complex problems. In this course we study machine representations and algorithms that allow machines to improve their performance on a defined task from experience. Instead of explicitly programming computers to perform a task, machine learning lets us program the computer to learn from examples and improve over time with or without human intervention. This requires addressing a difficult question: how to generalize beyond the examples that have been provided at training time to new examples that you see at test time. This course will show you how this generalization process can be formalized and implemented. We'll look at it from lots of different perspectives, illustrating the key concepts in the field.

This course is a broad overview of existing methods for machine learning and an introduction to adaptive systems in general. Emphasis is given to practical aspects of machine learning algorithms. The class format is split between quizzes, assignments, and course project. Each class consists of a lecture session and in-class lab session. The learning objective for each student is, once the student can understand the basics of machine learning technology, and the close connection between theory and practice they will have the ability to apply it to a wide range of applications in multiple fields.

LEARNING OUTCOMES

1. Understand the key concepts in machine learning. By the end of this course, students will be able to:
 - Identify potential applications of machine learning in practice.
 - Describe the core differences in analyses enabled by regression, classification, and clustering.
 - Select the appropriate machine learning task for a potential application.
 - Have the skills to apply regression, classification, clustering, retrieval, recommender systems, and deep learning techniques to make data-driven decisions.
 - Represent your data as features to serve as input to machine learning models.
 - Assess the model quality in terms of relevant error metrics for each task.
 - Implement techniques in Python.
2. Propose machine learning solutions to perform various artificial intelligence tasks. Towards this goal, students will:
 - Develop programming skills by writing code in Python
 - Experiment with machine learning libraries, including scikit-learn and TensorFlow
 - Evaluate machine learning algorithms for tasks in various application domains, including for analyzing text and analyzing images
3. Conduct and communicate original research. Towards this aim, students will:
 - Propose a novel research idea (this will be an iterative process)
 - Design and execute experiments to support the proposed idea
 - Write a course/research paper about the project (and possibly submit it for publication)
 - Present the project to the class.
