# **Course Description**

## UNIVERSITY CATALOG COURSE DESCRIPTION

Computer vision is a field of artificial intelligence (AI) that enables computing systems to extract meaningful information from digital images, videos, and other visual inputs to make computable decisions. The camera captures digital photos and videos in computer vision, and algorithms process and derives valuable information. Such information can help in making better decisions and recommendations.

With the rapid advances of AI in the last decade, computer vision is now more prevalent, and its impact on society is becoming quite evident. There are billions of images on the web. Smartphones and many other handheld devices generate countless images on social network platforms. With AI-driven applications embedded in smartphones, annotating and labeling pictures, objects, and artifacts of interest is becoming easier. On the other hand, industrial machinery regularly uses computer vision to classify defective items, and that scale is also multiplying. It is now becoming imperative to know the technology behind computer vision because, in the coming years, its ubiquitous nature will become part of society.

This introductory computer vision course provides a comprehensive review of the subject. This course emphasizes computer vision principles and highlights their applicability in the real world, from fashion to deep face recognition.



## PRE-REQUISITES FOR THE COURSE

We will not teach the Python programming. You are expected to know how to code in Python, which you will use in your PSETs.

#### LEARNING OUTCOMES

- 1. Get a broad view core computer vision concept, a critical precursor to effective collaborations in industry or academia.
- 2. Identify types of algorithms commonly used to solve each problem alongside their general properties that make them well-suited for the problem
- 3. Conduct research in computer vision to enhance their expertise on a topic of their choice. Deliver an oral presentation that explains the research. Review fellow students' presented research and provide constructive feedback. Communicate the research through a final report.
